CUSTOMER/CONTRACTOR/SUPPLIER/VISITOR CONFIDENTIALITY AGREEMENT

In consideration of disclosures ADVICS North America, Inc. This obligation of confidentiality will not apply to any information that (a) is already known by the undersigned at the time of its disclosure by ADVICS-NA and was obtained free of any obligation of confidentiality to or for the benefit of ADVICS-NA, (b) is lawfully obtained by the undersigned from a source other than ADVICS-NA having a right to disclose it, or (c) is or becomes public knowledge other than through a breach of this agreement by the undersigned.

The undersigned agrees to return to ADVICS-NA any and all confidential information in whatever form (including, but not limited to data, formulae, designs, specifications, processes, tooling, plans, or development samples), furnished to it by ADVICS-NA including copies thereof, when requested by ADVICS-NA.

The undersigned agrees that it will be responsible for insuring that each of its employees or agents who receive any confidential information are aware of and comply with the obligations imposed by this agreement.
